On September 1st, 2016, at a properly noticed public meeting and with a quorum of 9 of 11 Commissioners present, ANC 1B voted unanimously on the following items:

- ABRA-103008; Service Bar – 926-928 U St. NW, 1B02
The Commission voted to support the settlement agreement for Service Bar.
- ABRA-095180; Fasika – 1924 9th St. NW, 1B02
The Commission voted to protest the license on peace, order and quiet and designated Brad Gudzin as the primary ANC1B delegate. Further the Commission voted in opposition to the stipulated license.
- ABRA-103693; Capo – 715 Florida Ave. NW, 1B01
The Commission voted to protest this application on peace, order, and quiet.

With a quorum of 9 of 11 Commissioners present, ANC 1B voted 8 years, 1 nay, 0 abstention on the following item:

- ABRA-083219; U Street Music Hall – 1115 U St NW, 1B02
The Commission voted in support to extend operating hours to begin at 6 a.m., with no increase in alcohol sales hours.

The SMD Commissioner shall have primary responsibility to represent the Commission on matters within their SMD. Further, the Chair or any Commissioner or Committee Chair (Patrick Nelson, Nick Baumann, or Joshua Mater) or Brad Gudzin as (1B02 community representative) as delegate of the Chair, shall be authorized to communicate these actions to and testify before any agency of the Government of the District of Columbia or the members of the Council of the District of Columbia.
