On October 4, 2018, at a properly noticed public meeting and with a quorum of 12 of 12 Commissioners present, ANC 1B voted on the following items:

- **Brooklyn, ABRA-111411, CR**, 1212 U St, NW, 1B12
ANC 1B voted unanimously **to protest** on peace order and quiet, effect on parking and real property value pending approval of a settlement agreement at the November ANC meeting.
- **Broccoli Bar, ABRA-098584**, CT, 1817 7 St, NW, 1B01
ANC 1B voted unanimously **to support** the Settlement Agreement and support of the stipulated license pending final signatures on the submitted SA.
- **Service Bar, ABRA-103008**, CT, 926-928 U St NW, 1B02
ANC 1B voted unanimously **to support** modification of the Settlement Agreement - pending verification of consistent hours with other sidewalk cafes and that non-smoking signs are installed in the café area.

The SMD Commissioner shall have primary responsibility to stand for the Commission on matters within their SMD. Further, the Chair or, as defined on the attached, as delegate of the Chair, shall may communicate these actions to and testify before any agency of the Government of the District of Columbia or the members of the Council of the District of Columbia.
