Main agenda

- 625 T St NW
 - At the ANC 1B Economic Development Committee's previous meeting in March 2024, the committee had considered (and supported) an idea for a dog park at the 625 T St NW site, as presented by neighbor Mr. Parker Griffin. After that discussion, Commissioner Chair Tucker Jones became aware of other ideas for the use of the site, and asked that the full ANC not vote on the dog park idea until this alternative idea had a chance to be considered. This agenda item was about this alternative idea.
 - The property is owned by DC, specifically the Office of the Deputy Mayor for Planning and Economic Development (DMPED).
 - Jason Turner of T Street Development spoke about an idea he had called "Park Zero."
 - For background: T Street Development had had a license from DMPED to "activate" the site. At the time of this meeting, no entity or individual had an active license with DMPED to use the site.

- Mr. Turner's organization has applied for a modified license to use this site, for short term use and for a modification to allow for electric vehicle (EV) charging (see more below)
- Mr. Turner spoke about his organization's cooperation with the Greater Washington Region Clean Cities Coalition (GWRCCC) to apply for federal funds to put EV charging at the site.
- Mr. Turner also spoke about his organization's immediate-term plans to activate the site.
 - Mr. Turner said DC-based company Wow Wheelz would use the site in the interim.
 - Mr. Turner also said he had approached local business Lee's Flowers for use of the site.
- Mr. Chip Ellis, neighbor and owner of the Howard Theater, spoke in support of Park Zero.
- There was repeated questioning about why this site was ideal for electric vehicle charging (versus, for example, converting street parking into street parking + EV charging). Mr. Turner explained that the federal funding he's seeking limits
- Neighbor Mr. Parker Griffin spoke in opposition to "Park Zero" because he sees it as a parking lot, albeit one with electric vehicle charging, and does not see that as a good use of this site. He reiterated community support for the idea of a dog park at the site, including 280 neighbor sand over a dozen companies and neighborhood businesses and associations.
- Neighbor Ms. Samantha Sanders asked that the ANC stay open to other ideas for the use of the site.
- Motion: Committee member Howard Kurtzman moved that: the ZPD committee recommend that the full ANC support the further development and submission of proposals both for a dog park and for fast charging electric vehicle stations on the 625 T Street Northwest property, not precluding the development of alternative long-term proposals for the site; recommend that ANC 1B encourage the immediate activation of the site as described by Mr. Turner at this meeting; and authorize Chair Commissioner Tucker Jones to write a draft resolution to this end for ANC 1B's review and consideration.

 - The motion passed (3 in favor, 1 against, 0 abstaining, Chair not voting)

A RESOLUTION REGARDING SUPPORT FOR LONG-TERM USE OF DISTRICT-OWNED PROPERTY AT 625 T STREET NORTHWEST

WHEREAS the District of Columbia owns a vacant parcel of land at 625 T Street Northwest, under the Office of the Deputy Mayor for Planning and Economic Development (DMPED), and located within the area represented by Advisory Neighborhood Commission (ANC) 1B;

WHEREAS the parcel is in an area that ANC 1B, other government bodies, and other neighbors have identified as needing positive community, economic, and social activity;

WHEREAS the District of Columbia has previously attempted to activate the site by licensing the use of it to at least one local partner, but currently no partner holds a license to activate the site;

WHEREAS ANC 1B is aware of a proposal by neighbor Mr. Parker Griffin to request that the DC Department of Parks and Recreation (DPR) begin the process of looking into the use of this site for a publicly accessible dog park, tentatively known as the "North Shaw Dog Park";

WHEREAS ANC 1B is aware of a proposal by T Street Development to use the site to host "Park Zero," a green energy and green economy expo site centered around sufficient Level 3 electric vehicle charging equipment for up to six electric cars to be charged;

WHEREAS ANC 1B is aware that, in the interim period, T Street Development seeks to activate the site with programming around green energy and local business;

WHEREAS ANC 1B is aware that both the "North Shaw Dog Park" proposal and the "Park Zero" proposal are contingent on outside factors (for the "North Shaw Dog Park" proposal these factors include but are not limited to DPR review and availability of funding; for the "Park Zero" proposal these factors include but are not limited to over-all feasibility including the appropriateness of curb cuts on the sidewalk and the receipt of federal grant funds);

WHEREAS ANC 1B is aware that additional neighbors may seek additional or alternative visions for the use of the site;

BE IT FURTHER RESOLVED THAT ANC 1B reserves the right to withdraw, modify, or condition its support further as each the "North Shaw Dog Park" proposal and the "Park Zero" proposal move forward in their respective processes;

Fiscal Year 2025 Budget - Transportation and Public Space Resolution

Whereas Mayor Muriel Bowser presented the Fiscal Year 2025 budget proposal to the Council of the District of Columbia on April 3, 2024,

Whereas The Council of the District of Columbia is currently reviewing the Fiscal Year 2025 budget for markup and will complete a final version of budget for transmission to the Mayor in the beginning of June 2024,

Whereas Numerous provisions of the operating budget, capital budget, and budget support act affect ANC 1B and its residents,

Therefore be it resolved that ANC 1B supports the following components of the budget as proposed:

- Continuation of existing bus priority project capital funding, as four of these projects pass through ANC 1B (U Street NW, Florida Avenue NW, 14th Street NW, and 7th Street NW).
- The proposed purchase and installation by the Department of Public Works (DPW) of public "smart composting" containers in multi-family areas.
- The proposed purchase and installation of public trash compactors in high-traffic and high-litter commercial areas.
- Additional funding to support a regional commitment to fill WMATA's operational funding gap.
- Continued expansion of the Capital Bikeshare network, including the addition of electric bicycles.
- Maintaining continuing funding for overnight buses, several of which run through ANC 1B (52, 70, 90).
- The inclusion of the U Street Streetscape from 14th Street NW to 18th Street NW in the capital budget.

Be it further resolved that ANC 1B opposes the following revisions in the budget

- The elimination of the DC Circulator, including the current Woodley Park-Adams Morgan Circulator route and the future Georgetown-Dupont-U Street Circulator route through ANC 1B without an implemented and funded plan to replace these routes with substitute service from MetroBus.
- Cuts to the Department of Public Works' booting and towing teams, which would worsen the traffic safety and illegal parking situation in ANC 1B.
- The elimination of the U Street performance parking zone's special fund intended to create a community improvement district in the U Street area, a much needed place based entity to support residents and visitors to the area.
- The elimination of language that would direct excess automated traffic enforcement revenue to traffic safety programs instead of general revenue.

Be it further resolved that ANC 1B recommends the following changes

- Enhanced capital funding for FY26-FY29 to allow for the District Department of Transportation to purchase new bus shelters in support of a new bus shelter franchise agreement.
- Reallocating any remaining capital funding remaining from the Florida Avenue reconstruction project to address minor mitigations requested by ANC 1B.
- Two additional FTEs for the District Department of Transportation (DDOT) bicycle storage team to allow for the evaluation and installation of additional bike racks across the District.
- Further funding to support the ADA reserved pilot parking program currently being developed by DDOT 's curbside management team and piloted in ANC 1B.
- Expansion of funding for DDOT's tactical hardening program from \$700,000 over the course of the capital budget to \$5,000,000 over the course of the capital budget.
 - To achieve this, ANC 1B recommends reprogramming funding currently allocated to widen the I-695 offramp to 11th Street SE.

 - i. Applicant name: Carlos L. Piana for owner Minh Trinh
 - ii. Contact: caco1978@gmail.com; minh.dmv@gmail.com
 - iii. Property: 2023 11th Street NW (Square 0332, lot 0801; Greater U Street Historic District, zoned ARTS-2)
 - iv. Case number: HPA 24-223
 - v. Request of committee: Addition to the back of an existing townhouse to allow two more units (in addition to existing two, for a total of four).
 - 1. This is allowed by the existing zoning (by-right with respect to zoning) so the request is just for historic compatibility.
 - 2. The applicant demonstrated that per their rendering, the proposed addition will not be visible from the street, except for one particular angle.
 - vi. SMD/Commissioner: 1B02, currently vacant.

- vii. Summary of discussion:
 - 1. Committee member Heisey spoke against the proposed addition on grounds of scale (massing and height).
 - 2. Committee member Chauvin spoke about some of the building materials that he thought looked historically incompatible for the area, notably some side panels.
 - 3. Committee member Gaal had specific questions about project details.
 - 4. Commissioner chair Jones spoke in favor of the addition as proposed, as the changes will not be visible from the street except for the one particular place along the far sidewalk. Mr. Jones also noted that even at that one angle, the applicant had made efforts to blend the addition in with the original property, and that he found these efforts sufficient.
- viii. Motion:
 - Committee member Gaal moved that the ZPD committee recommend that the full ANC support the application for 2023 11th St NW as presented, with the following exception: material change of side paneling to brick-looking material.
 - 2. The motion was seconded. The motion passed (2 in favor, 1 against, 0 abstentions, chair not voting).
